## 2012 Contingency Claim Form

Any CRA Novice/Expert having started in a minimum of (9) of the CRA's Ninja 250 Sprint Races between May-Aug. weekends, will qualify for this Sept. Weekend Contingency. Note that there is no (9) race start requirement for a visiting club racer (ex: MRA) to compete in the CRA's Ninja 250 Class Sept. Weekend Contingency. **Contingency payouts will be determined by total Sept. weekend points**. Racers who qualify for a payout, will receive one payout per the Sept. CRA event\*, and not for individual races.

Payout Schedule: Expert: 1st-\$1000, 2nd-\$500, 3rd-\$250

Novice: 1st-\$1000, 2nd-\$500, 3rd-\$250

Please note: Any racer who is displaying logos from a dealer other than Rocky Mountain Kawasaki, is not eligible for this contingency. **Requirements:** 

- 1. Bob Fier Racing and Rocky Mountain Kawasaki stickers must be displayed on both sides of the motorcycle.
- 2. Racer must list Bob Fier Racing as a sponsor.
- 3. Racer must fill out and return this form to the CRA before his/her first race of the weekend.
- 4. Racer must behave in a professional manner, and display good sportsman conduct at all CRA events. Failure to do so will result in ineligibility for this contingency.
